As a professional body representing prescribers, we understand our responsibility to reduce this by promoting sustainable prescribing. Together with Royal College of GPs in Scotland we are leading the way in creating a global movement for sustainable prescribing, a movement which is enthusiastically supported by Scottish Government.

We have issued a joint statement, which is supported by over ten health professional leadership bodies in Scotland, which calls for wide ranging action to be taken by policy makers, education providers, NHS leaders and the pharmaceutical industry.
