Our policy is that e-cigarettes and other NVP products should be treated in exactly the same way as tobacco smoking. They are not harm free and as such they should not be encouraged within a healthcare facility. While there is not yet the same body of evidence against secondary exposure to vapour as is established for passive tobacco smoking, there are still challenges for some people e.g. asthmatics. In the same way as tobacco they should not be used in enclosed spaces. A pragmatic approach would therefore be enforce the same rules for vaping as for tobacco smoking and ensure this activity is is kept well away from entrances and anywhere that would expose young people to this activity.

There should also be information visible and available on "Thinking of Quitting? and" where to obtain smoking cessation support locally, including at community pharmacies.
