It is important for patient safety that every individual providing independent health care services, regardless of profession, is regulated. There should not be variation between the requirement for regulation of one profession over another.

It is also an important principle that all independent healthcare services provided by registered healthcare professionals should be regulated, regardless of the setting in which they operate.

As stated above, ensuring that all independent health care services are regulated will improve patient safety. It is important that premises are appropriate for the provision of health care services, however, registration and regulation should not be dependent on the setting. Both premises and the practitioner should be registered to ensure healthcare services are being offered from a safe, hygienic and appropriate location by a practitioner registered to provide those services and who will do so to an appropriate standard.

It will be very important for consistency of practice that the regulation aligns well with General Pharmaceutical Council (GPC) regulations. Royal Pharmaceutical Society strongly suggests collaborative working with GPhC to get this right, otherwise there is a risk of confusion when pharmacists and other healthcare professionals are working between different settings.

Furthermore, the introduction of regulation will require some online providers to potentially have multiple registrations with the CQC (if also operating in England), GPhC (for pharmacy services) and HIS. This could lead to an overduplication of regulation, with multiple inspections. A system should be introduced to recognise inspections carried out by partner providers to streamline the process. The consultation paper states that "the 4 UK home nations will work cooperatively to regulate and inspect the services based in their jurisdiction." This is incredibly important to ensure any additional system of regulation is not too burdensome for providers who are already registered with more than one regulator.

It will be important to ensure that all prescribing professionals are included in the scope of this regulation to future proof this work to include those who are not yet but may become prescribers in the future. Without this, there is a risk that other prescribing professionals will then fall outside of the legislation and less scrupulous providers may use this loophole to continue to provide unregulated independent healthcare, which would go against the spirit of regulation.

3 Do you agree that independent medical agencies where services are provided by a medical practitioner, dental practitioner, registered nurse, registered midwife, dental care professional, pharmacist or pharmacy technician should be regulated by Healthcare Improvement Scotland?

As it is proposed that Healthcare Improvement Scotland will regulate healthcare professionals providing healthcare services in Scotland outwith the NHS and registered premises, for consistency it would make sense for HIS to also regulate independent agencies operating entirely online.

Services should be provided to a minimum safe and appropriate validated standard, whether the service is offered online or in-person.

There should also be consideration given to whether it is appropriate for the services in question to be offered online or whether in-person provision is required to ensure safe, high-quality care.

Therefore, implementation of this regulation has the potential to tackle health inequalities.
